### Introduction

The purpose of this report is to provide pertinent public health information to public health, healthcare providers and other community stakeholders, as well as to the general public. This report replaces the Nevada State Health Division (NSHD) weekly influenza report and will be published on the first and third Friday of each month.

### Nevada State Public Health Laboratory Counts

According to the Nevada State Public Health Laboratory (NSHPL), as of 1:00pm PT, September 3, 2009, Nevada had 917 **confirmed** cases of H1N1 flu and 38 **probable** cases. All of the probable cases, with one exception, are due to samples with viral loads too low for subtyping. **\*\*Does not include private laboratory testing\*\***

## Seasonal Influenza Activity

According to the CDC, for MMWR week 33 (August 16-22, 2009), influenza activity remained stable or continued to decline in most areas of the U.S., with the exception of increased activity in the Southeast. Nationwide a total of 8,843 hospitalizations and 556 deaths associated with 2009 H1N1 influenza viruses have been reported to the CDC, an increase from 7,983 hospitalizations and 522 deaths from the prior week.

There are 5 levels of influenza activity as defined by the CDC.

- **No Activity:** No laboratory-confirmed cases of influenza and no reported increase in the number of cases of ILI.
- **Sporadic:** Small numbers of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.
- **Local:** Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in a single region of the state.
- **Regional:** Outbreaks of influenza or increases in ILI and recent laboratory confirmed influenza in at least two but less than half the regions of the state with recent laboratory evidence of influenza in those regions.
- **Widespread:** Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

For MMWR week 33:

- 2 states reported **widespread** activity
- 13 states reported **regional** activity
- 10 states reported **local** activity
- 24 states reported **sporadic** activity
- 1 states reported **no activity**

Nevada has 5 reporting regions. For MMWR week 33, we are at “**regional**” influenza activity.

## H1N1 Supplemental Funding – Phase III

An additional \$846 million in Public Health Emergency Response (PHER) Phase III funding is available for the implementation of the 2009 H1N1 influenza mass vaccination campaign expected to begin in mid-October 2009. These funds supplement the \$248 million provided in August (PHER – Phase II) and the \$260 million provided in July (PHER – Phase I). Nevada will receive \$13,765,554 in federal funding from the following grants:

- \$ PHER – Phase III - \$8,047,201
- \$ PHER – Phase II - \$2,846,559
- \$ PHER – Phase I – \$2,134,789
- \$ Hospital Preparedness - \$737,005

PHER – Phase I funding is divided into two focus areas:

- Focus Area 1 – Vaccination, Antiviral Distribution/Dispensing and Administration, Community Mitigation and Other Associated Pandemic Preparedness and Response Activities (\$1,601,092)
- Focus Area 2 – Laboratory, Epidemiology, Surveillance, and Other Associated Pandemic Preparedness and Response Activities (\$533,697)

PHER – Phase II funding is provided to augment Focus Area 1 activities. Focus Area 2 activities are not included in this additional funding.

PHER – Phase III funding is intended to fund for vaccination administration at the state, local, tribal, and territorial levels, to enhance the capabilities of the private sector to administer vaccine and to address any remaining mass vaccination-related implementation gaps identified during PHER – Phase I and Phase II planning.

## **National Preparedness Month (NPM) 2009**

National Preparedness Month (NPM) is sponsored by the *Ready* Campaign and Citizen Corps. NPM is held each September to encourage Americans to take simple steps to prepare for emergencies in their homes, businesses and communities.

This year marks the sixth annual NPM. NPM 2009 will focus on changing perceptions about emergency preparedness and helping Americans understand what it truly means to be "*Ready*".

## **West Nile Virus Prevention**

These actions will help protect you and others against West Nile virus:

- Avoid mosquito bites
  - Wear long sleeve shirts, long pants and socks
  - Use insect repellent containing DEET (look for N, N-diethyl-m-toluamide) on exposed skin when outdoors
  - Use insect repellent according to directions
- Mosquito-proof your home
  - Install or repair window and door screens
  - Drain standing water so mosquitoes do not have a place to breed
  - Empty water from buckets, cans, pools covers, flower pots and other items
